Dear Sir or Madam,

Bankruptcy proceedings for Visir Sport AS, registration number NO 927 070 448, were opened on 25 July 2023, pursuant to a petition for winding up.

The District Court of Agder (Agder tingrett) has appointed me, Bjørn Hübert Senum, (advokat/attorney-at-law), Trustee/Administrator. Kjell Arnvard is appointed auditor for the estate.

I attach the final report to the Court (in Norwegian).

There will be no payment to ordinary creditors.

The Wage Guarantee Scheme has paid a total of NOK 219,382 to four employees (wages and holiday allowances), and their refund claim against the bankruptcy estate has first priority according to law. Therefore, the Wage Guarantee is the only creditor that will receive any payment from the estate.

A meeting to review the Wage Guarantee's refund claim will be held in my office, Tollbodgata 40, Kristiansand, on Monday 20 January 2025 at 13:00 hrs. The debtor and a representative of the Wage Guarantee may attend the meeting, but this is not required.


